II. SUBJECT

II.1. The subject of this contract is:

Providing the LICENCE of Digital colour orthophotomap, owned and copyrighted by Supplier, to the Client for the use for the project LUCAS, covering limited territories (polygons) according to the specification of LUCAS project and providing copies of orthophotomaps to specified coordination center (EUROSTAT) according to the specification of LUCAS project.

Orthophotomaps at resolution 50cm/pixel are processed / based on aerial photoflight at the ground resolution max. 25cm/pixel from the period 2011-2013 in parameters according to point III. for the purpose of consequent.

III. SPECIFICATION

III.1. Parameters of continuous colour digital orthophotomap:

The digital orthophotomap will be georeferenced into coordinate system S-JTSK. Position precision of digital orthophotomap: **maximum position mean error (max. RMSE) of elements image on the terrain is 1,5 m.**

Pixel resolution of the digital orthophotomap is 50 cm.

Digital orthophotomap will be consequently cut on formats and delivered to the client on memory media DVD in digital form in raster formats *.TIF in state coordinate system SJTSK with files *TFW allowing direct georeferencing of orthophotomap files in ArcGIS .

IV.1. Price for the specific licence of digital orthophotomap in frame of this contract and provide of copyright for the use of orthophotomap for LUCAS coordination center is:
