BREEDING LOAN AGREEMENT

This Breeding Loan Agreement, entered into by

ZOO SZEGED (Loaning Institution) 6725 Szeged, Cserepes sor 47. Hungary

and

ZOO KOSICE (Receiving Institution) 040 01 Kosice - Kavečany, Ulica k Zoologická záhrad 1. Slovakia

concerning the following specimen identified as follows:

0.0.1 Eurasian griffon vulture (Gyps fulvus) 953000010620194

and will remain in effect until terminated. The listed specimen is the property of the Serbian government.

I. Obligations of the Loaning Institution:

- 1. It is agreed that in the event of diseases, injury or death of the specimen except for negligence, the receiving institution, its agents and employees will be free of all responsibility to the loaning institution.
- 2. A detailed copy of all information pertaining to the specimen including, but not restricted to, behavioural traits, medical and reproductive history, diet, origin and all other pertinent data will be provided by the loaning institution.
- 3. In the event of intention to sell, trade or otherwise dispose of the specimen, the receiving institution shall be given the first right of refusal.

II. Obligations of the Receiving Institution:

1. The receiving institution will provide adequate housing, diet, veterinary, veterinary care and other necessities conductive to the well-being and reproduction of the specimen. Under certain circumstances (bachelor herds, etc.), the specimen may be placed in a non-reproductive situation, but will be maintained in compliance with the above, for subsequent reintroduction into a potential reproductive situation.

- 2. The transfer of the listed animal is carried out by Zoo Szeged. There shall be no monetary compensation between the parties, but both institutions shall cooperate in the move as appropriate.
- 3. In the event of the specimen being subjected to high-risk veterinary or husbandry procedures, permission must first be obtained by phone from the loaning institution before the performance of such procedures. Obtainment of permission may be neglected in the event of an emergency. Details of such procedures shall be provided in writing to the loaning institution within 10 days.

For any research project in which the specimen may be subjected to manipulation, stress or high-risk procedures, permission must be obtained in writing from the appropriate official of the loaning institution.

- 4. The specimen described in this document will not be transferred to another location outside the receiving institution's contiguous property without first obtaining permission from the loaning institution.
- 5. The loaning institution will be notified within 30 days of mortality of specimens. Births, hatchings, serious illness or the escape of the specimen shall be reported within 30 days.
- 6. In the event of death of the specimen, a detailed necropsy will be performed by the receiving institution and the findings will be sent to the loaning institution.

7. The carcass and its parts remain the property of the loaning institution. The final disposition of the carcass and / or parts will be the decision and responsibility of the loaning institution.

- 8. The receiving institution will provide all information necessary to maintain appropriate studbooks and record-keeping systems, and provide such information to the loaning institution, along with a yearly status report of the specimen.
- 9. A copy of all pertinent records will be sent to the loaning institution upon termination of this agreement.
- 10. The loaning institution will be free of any responsibility for any personal injury of property damage due to any accident, escape or mishap resulting from this breeding loan.

III. Obligations of Both Institutions:

- 1. All transportation expenses incurred in shipping the specimen to the receiving institution will be borne by the receiving institution, transportation expenses for returning the specimen to the loaning institution will be borne by the loaning institution.
- 2. The term of this Agreement is indefinite, but each one of the parties shall be entitled to terminate it.
- 3. Either institution may terminate this agreement by giving the other institution 30 days written notice prior to the effective date of the proposed termination.

4. Prior to the shipping of the specimen, the receiving institution must be notified at least 14 days in advance; and specific shipping information provided at least 24 hours in advance of actual shipment.
