### Article 1 – Scope and objective of the cooperation

- 1.1. The Parties intend to cooperate in a bilateral initiative within fund for Bilateral Relations within the programme "Culture" call no. CLTBF05 announced by Ministry of Investments, Regional Development and Informatization of the Slovak Republic Government Office of the Slovak Republic as a program administrator for the program Cultural entrepreneurship, cultural heritage and cultural cooperation (hereinafter "the Program administrator"). The initiative "Sustainability in cultural industry art in public space" (hereinafter referred to as the "Initiative"), which the Parties plan to implement from July 2023 to November 2023. The event will take place in Norway.
- 1.2. The main objective of the initiative with regard to bilateral relations between the Parties is organizing a joint bilateral event with focus on sharing and transfer of knowledge, technology, experience and best practise in cultural area in Norway and Slovakia.
- 1.3. Due to the impossibility of fulfilling the Initiate due to the objective reason, e.g. pandemic situation, mitigation plan described in application form will be followed.

#### Article 2 – Main roles and responsibilities of the Parties

- 2.1. The Parties commit to cooperate at each stage of the Initiative, i.e. during the preparation of the conference days, evaluation of the initiative and the follow-up activities.
- 2.2. The Applicant will appoint project manager who will coordinate project managers appointed by Partners to ensure proper implementing of the Initiative.
- 2.3. Project managers will cooperate by preparing documentation, supporting documentation related to project implementation and reporting.

#### Article 3 – Obligations of the Applicant within implementation of Initiative

- 3.1. Organizing conference days in cooperation with Partners. Communication with Partners regarding Initiation Meeting which will take place in Telemark museum in Norway.
- 3.2. Applicant will be responsible for preparation supporting documentation for grant application, reporting and proper implementing of the Initiative. The applicant will carry out administration tasks related to Initiative.
- 3.3. Disseminating the results of the Initiative.

## Article 4 – Obligations of the Partner within implementation of Initiative

- 4.1. The role of the partners is mutual exchange of information about the possibilities of supporting the new generation of artists and craftsmen in the field of ceramics and porcelain production. The topic will be focused on the sustainability of craft and the role of art in public space.
- 4.2. The project partners will actively participate in the organization of the conference with regard to examples of good practice and exchange of experience.

4.3. The project partners will cooperate with the project applicant by administration of application form, financial reports and publicity of the Initiative.
