## 7.4. Mentoring and monitoring arrangements

As a minimum, the monitoring and mentoring arrangements will include the following activities:

Regularly scheduled one on one and group meetings to discuss progress, set goals, and address any issues. Constructive feedback sessions to discuss strengths and areas for improvement. Direct observation of work or activities to provide real-time feedback. Regularly reviewing progress towards these goals and making necessary adjustments. Sharing available educational resources. Providing access to tools and resources that can aid in development. Offering advice on how to approach and solve specific problems. Providing moral support and encouragement. Encouraging self-reflection and critical thinking about experiences and learning.

The tutors and teachers will provide also post-mobility counselling and support to help students integrate their learning outcomes into their future academic and career plans.

# 8. Evaluation of learning outcomes

After the mobility activity, the participant's learning outcomes will be assessed in the following way:

### **Evaluation format:**

Peer and Mentor review. Participants present their work and receive constructive feedback focusing on strengths, areas for improvement. Self-reflection through presentation of the final projects, explaining the design choices, and any obstacles encountered and overcame during the process

According to the assessment (the quality, complexity, and creativity of a final 3D model project)

#### **Evaluation procedures:**

The evaluation process and procedures will take place at the sending and at the hosting organisation too, the evaluators will be the peers/ mentors and art teachers. The participants will receive a written evaluation from the tutor and supervising teacher.
