# EBU Member Confirmation of Media Rights World Aquatics 2024-2026

This EBU Member Confirmation of Media Rights is made on 24 October 2024

(the "Rights Confirmation")

#### THE EUROPEAN BROADCASTING UNION

L'Ancienne-Route 17A 1218 Le Grand-Saconnex, Geneva Switzerland (the "**EBU**")

#### Slovak Television and Radio

Mlynska Dolina Bratislava 845 45 Slovakia (the "**Licensee**")

Hereinafter collectively referred to as the "Parties" or individually as the "Party".

#### WHEREAS:

- A. World Aquatics ("AQUA"), whose principal place of activity is at Chemin de Bellevue 24a/24b, 1005 Lausanne, Switzerland, is the sole and exclusive world governing body of the Sport of Aquatics which incorporates the aquatic sports of swimming, open water swimming, diving, artistic swimming, water polo, high diving and masters swimming, and any other aquatic sport that may be governed by World Aquatics from time to time and owns all the rights in respect of the World Aquatics Events 2024-26, including the televisual, digital and other audio-visual rights.
- **B.** On 01.07.2024 Act No. 157/2024 Coll. on Slovak Television and Radio and on Amendments to Certain Acts entered into force, which abolished Radio and Television of Slovakia on the effective date and, pursuant to Section 30(1), its legal successor became Slovak Television and Radio, which assumed all of its rights and obligations.
- C. The EBU has been granted the Media Rights by AQUA by means of a binding written agreement, attached hereto as Schedule 1 (the "Media Rights Agreement") in respect of the Events which have been acquired by EBU by means of a joint acquisition on behalf of certain EBU Members, including the Licensee.
- **D.** This Rights Confirmation, together with the Media Rights Agreement, which shall form an integral part of the Rights Confirmation, sets out the terms and conditions upon which the Media Rights shall be granted by EBU to Licensee to broadcast the Events in the Territory during the Term in the Language.
- E. The Summary of Essential Commercial Terms sets out the commercial terms upon which EBU grants the Media Rights to Licensee and in case of any limitations to or deviations from the Media Rights Agreement set out therein, the Summary of Essential



Terms shall be relevant and prevail.

- **F.** Upon request of Licensee, Licensor provides Licensee with a Rights Confirmation before finalization and signature of the Media Rights Agreement. Licensee acknowledges and agrees that some Essential Commercial Terms may be modified at a later stage during the contract negotiations between AQUA and Licensor. After signature of the Media Rights Agreement, Licensor will provide Licensee with an updated Rights Confirmation.
- **G.** By acknowledging receipt of this Rights Confirmation (email by an authorized signatory from Licensee to be sufficient), Licensee acknowledges and agrees to the terms and conditions set out in this Rights Confirmation.

All capitalised expressions used in this Rights Confirmation shall have their respective meanings defined herein or in the Media Rights Agreement unless the context expressly requires otherwise.

# 10. RESERVED RIGHTS

Without prejudice to the Media Rights granted under this Rights Confirmation, Licensee acknowledges and agrees the following reserved rights for AQUA and the EBU:

#### (a) AQUA reserved rights

Licensee acknowledges and agrees that AQUA shall be entitled to the reserved rights as defined in clause 3.7 and 3.8 of the Media Rights Agreement.

#### (b) EBU reserved rights

Licensee further acknowledges and agrees that EBU shall be entitled to retain:

- Pay TV rights for exploitation on a regional or territory-by-territory basis;
- Pan-European rights for exploitation on a free and/or pay basis;
- Non-exclusive digital (live & VoD) rights for all Events for exploitation on the EBU digital platform. For the avoidance of doubt, the EBU digital platform is not intended to compete with Licensee's coverage of the Events but it aims at guaranteeing blanket coverage of the Events throughout the Territory. Furthermore, the exploitation of rights on the EBU digital platform will not entail additional costs for Licensee; and
- Non-exclusive clip rights for exploitation on a pan-European, regional or territory-by-territory basis.

#### Miscellaneous

- 1. Neither Party nor any of its employees shall divulge to any third party (other than affiliated companies or in the case of EBU, to its affiliates and AQUA or their agent or financial or legal advisers) any of the terms of this Rights Confirmation without the express written permission of the other, save as may be necessary in order to comply with any legal or regulatory requirements. This Clause shall survive the expiry or termination of this Rights Confirmation.
- 2. The parties expressly acknowledge that all acts relating to the subject matter of this contract that were performed prior to the effective date of this contract shall be deemed to be acts within the meaning of this contract
- 3. Applicable Laws and Regulations, Dispute Resolution

The Media Rights have been acquired by EBU by means of a joint acquisition in the framework of Eurovision, and the Statutes of the EBU, the EBU Code of Finance and the EBU Sports Rights Acquisition Rules and Procedure fully apply to the grant of Media Rights by EBU to Licensee under this Rights Confirmation.

Licensor acknowledges and agrees that, in compliance with §47 a) of the Act No.40/1964 Collection Civil Code of the Slovak Republic as amended by §5 a) of the Act No. 211/2000 Coll. on free access to information and on amendments and supplement to certain acts (Freedom of Information Act), STVR will publish a redacted



copy of this Agreement, the redaction to be approved in writing by Licensor, via Central Register of Contracts of the Government Office of Slovak Republic. Such publication by STVR shall not be a breach of this provision.

The parties expressly acknowledge that all acts relating to the subject matter of this contract which have been performed prior to the effective date of this contract shall be deemed to have been performed within the meaning of this contract.

The interpretation, construction and effect of this Rights Confirmation shall be governed in all respects by the laws of Switzerland. Where a claim or dispute arising out of or in connection with this Rights Confirmation, including any question regarding its existence, validity or termination, is not settled by negotiation, the EBU Sport Presidency shall be entitled to suggest an appropriate remedy or sanction, unless a conflict of interests exists, in which case the concerned party / member of the EBU Sport Presidency must recuse himself/herself.

If the mediation procedure described above does not resolve the dispute, either Party may proceed with arbitration by written notice to the other Party. In the event that a Party proceeds with arbitration, any claim or dispute arising out of or in connection with this Rights Confirmation, including disputes on its conclusion, binding effect, amendment and termination, shall be resolved, to the exclusion of the ordinary courts in accordance with the Rules of Arbitration for the time being in force of the Swiss Rules of International Arbitration of the Swiss Chambers' Arbitration Institution. A three-person arbitral tribunal shall be appointed, one (1) arbitrator to be appointed by each party and the third by the appointed arbitrators in accordance with the Swiss Rules of International Arbitration of the Swiss Chambers' Arbitration Institution. The decision of the arbitral tribunal shall be final and binding on the Parties. Each Party bears its own costs.
