SHORT FORM BROADCAST AGREEMENT dated 01st tof October 2024

FIBA Europe Properties GmbH (to be further referred to as "FEP"), Ismaningerstrasse 21, 81576 Munich, Germany, duly represented by Monika Puchner, authorized with sole power of representation, entering into an Agreement with Slovenska televizia a rozhlas, , duly incorporated under Slovakian law with registered offices at Mlynska dolina, 845 45 Bratislava, Slovakia and with VAT, duly represented by Igor Slanina, deputy general director (to be further referred to as "Licensee")

Preamble

Whereas, FIBA Europe e.V. ("FIBA Europe") is a registered association under the laws of the Federal Republic of Germany and is recognised as a non-profit making organisation. Whereas, FIBA Europe entered into an agreement with FIBA Europe Properties GmbH ("FEP") according to which FEP acquired, inter alia, all commercial exploitation rights in connection with the FIBA EuroCup Women and FIBA Europe Cup Men ("Competitions").

The details are as follows:

License Term

From 8 of October 2024 until 05 of February 2025

Competitions:

All Away Games of Patrioti Levice (3) and BC Prievizda (3) in the FIBA Europe Cup Men during the Regular Season and the 2nd Round.

(the "Competition Games"):

Licensed Territory

Slovakia

Licensed Language

Slovakian

Licensed Rights

FEP shall grant to Licensee the following exclusive live transmission TV Rights in the Licensed Territory, subject to proper geo/blocking:

- The right to broadcast the Competition Games in the Licensed Territory by Free TV, Analogue and/or Digital, Terrestrial and/or Cable and/or Satellite Television on all channels owned by STVR.
- The right to broadcast the Competition Games in the Licensed Territory by the Internet, IPTV, Internet TV and Mobile
- The right to record the transmissions on to Beta SP or Beta Digital Tapes or another such format for repeat transmissions;



The rights of 7 Days Catch Up.

Notwithstanding the foregoing, Licensee acknowledges that all other rights not mentioned above shall remain the exclusive property of FIBA Europe. FIBA Europe shall have the right to stream all Competition Games live or delayed in full length and/or in excerpts on their YouTube channel.

Licensee shall have the right to use excerpts of the Competition games, photos and logos (subject to availability) within promotional clips to promote and advertise the licensed content.

Consideration

Licensee shall pay to FEP the following amounts:

For the Games during the Regular Season and the 2nd Round Licensee shall pay EUR 1.053,per Game net License fee + VAT if applicable.

All payments by Licensee shall be exclusive of value added tax and free and clear and without deductions based on any currency control restrictions, import duties, or any sales, use, value added or other taxes or withholdings or bank charges.

Licensee shall make the payment 30 business days upon contract signature and receipt of the corresponding invoice(s).

Sublicensing:

Licensee shall have the right to sublicense the afore mentioned audio-visual media broadcasting rights within STVR media group only.

Ownership of the Licensed Rights. Indemnity:

FEP represents and warrants that (i) FIBA Europe is the sole and exclusive owner of the Licensed Rights, free from any liens and encumbrances; (ii) FEP is duly authorized to grant the Licensed Rights to Licensee under this Agreement in accordance with the agreement entered into between FEP and FIBA Europe as described in the Preamble; and (iii) there are not any other third party rights over the Licensed Rights within the Licensed Territory which may breach the exclusivity on the Licensed Rights within the Licensed Territory granted to Licensee under this Agreement.

Miscellaneous:

Other conditions of the use and grant of the TV rights not stipulated in this term sheet, if any, shall be the subject of a supplementary Agreement, to be eventually signed by both Parties.

The terms of this Agreement shall be legally binding.

The interpretation, construction and effect of this Agreement shall be governed in all respects by the Laws of Germany.

Any dispute arising from or related to this Agreement including disputes as to its validity, binding effect, amendment and effective termination will be submitted exclusively to the Court of Arbitration for Sport in Lausanne, Switzerland, and resolved definitively in

accordance with the Code of sports-related arbitration. The language of the arbitration will be English. Any decision of the Court of Arbitration for Sport shall be final and binding on the parties.

FEP acknowledges that by virtue of the Licensee's usual distribution of the channel(s), each such channel (including Competitions transmitted in accordance with this Agreement as part of such channel) may be received at commercial premises such as bars, clubs, restaurants and hotels in the Territory and viewed on normal or large screens at such locations.

Licensor acknowledges and agrees that, in compliance with §47 a) of the Act No.40/1964 Collection Civil Code of the Slovak Republic as amended by §5 a) of the Act No. 211/2000 Coll. on free access to information and on amendments and supplement to certain acts (Freedom of Information Act), STVR will publish a redacted copy of this Agreement, the redaction to be approved in writing by Licensor, via Central Register of Contracts of the Government Office of Slovak Republic. Such publication by STVR shall not be a breach of this provision.

The parties hereto expressly acknowledge the full force and effect of the present Agreement and other corresponding documents provided by this Agreement, which can be executed by qualified electronic signature or by hand by FEP and which may be executed by Licensee by hand.
