



MEMORANDUM OF UNDERSTANDING
BETWEEN
SLOVAK UNIVERSITY OF AGRICULTURE IN NITRA
AND
BURYAT STATE ACADEMY OF AGRICULTURE NAMED AFTER
V.R.PHILIPPOV IN ULAN-UDE

The Slovak University of Agriculture in Nitra (SUA), Slovak Republic, and Buryat State Academy of Agriculture named after V. Philippov (BSAA), believe that the expansion and strengthening of scientific and educational cooperation is of mutual value to both institutions, hereby agree to enter into a Memorandum of Understanding.

1. Purpose of Memorandum of Understanding

The purpose of this Memorandum of Understanding is to facilitate world-wide research cooperation, as well as to develop new networks and partnerships and thus to support the development and the innovation, to transfer and to implement the results of research and development, to promote the exchange of staff and other forms of scientific cooperation between the Slovak University of Agriculture in Nitra and Buryat State Academy of Agriculture named after V. Philippov in Ulan-Ude. The aim of the cooperation is also to support the activities of AgroBioTech Research Centre established at SUA. This agreement establishes the general principles and conditions under which the cooperation will be pursued. Eventual cooperation activities and projects will be subject to more detailed agreements.

2. Scope of Cooperation

Subject to mutual consent, the areas of cooperation will eventually include any programme offered at either institution that is felt desirable and feasible on either side and which both sides feel will contribute to the fostering and development of the cooperative relationships between the two institutions.

3. Terms of Cooperation

The terms of cooperation for each specific activity implemented under this agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.



Establishment of AgroBioTech Research Centre

Any such agreements entered into, as outlined above, shall bear reference to this Memorandum of Understanding. Each institution shall designate a coordination unit to be responsible for the development and coordination of the cooperation activities agreed upon in different fields.

4. Renewal, Termination and Amendment

This cooperative agreement shall remain in force for a period of five (5) years from the date of the last signature and may be extended by mutual agreement. It may be terminated by the appropriate authorities of either party giving six (6) months notice to the other party in writing. An earlier termination date is possible when mutually agreed upon. The agreement may be amended by mutual written consent of the two parties.

This Agreement does not impose any legal and financial obligation to the participating institutions.

This Agreement is signed by the responsible authority of each institution. It will be coordinated by at the Slovak University of Agriculture in Nitra and by at Buryat State Academy of Agriculture named after V. Philippov.
